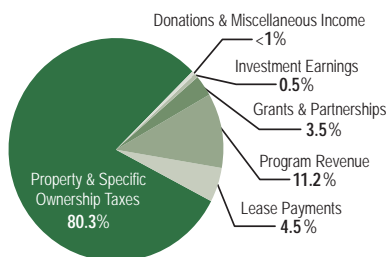

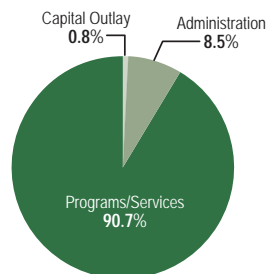
2008 revenues, total
